Extracts from the Firearms Act 1968

‘Section 21’

(1) A person who has been sentenced (to custody for life or) to preventive detention, or to imprisonment or to corrective training for a term of three years or more (or to youth custody (or detention in a young offender institution) for such a term), or who has been sentenced to be detained for such a term in a young offenders institution in Scotland, shall not at any time have a firearm or ammunition in his possession.

(2) A person who has been sentenced to imprisonment for a term of three months or more but less than three years (or to youth custody (or detention in a young offender institution) for such a term), or who has been sentenced to be detained for such a term in a detention centre or in a young offenders institution In Scotland, shall not at any time before the expiration of the period of five years from the date of his release have a firearm or ammunition in his possession.

This means:

Section 21 prohibits the possession of a firearm and ammunition (under any circumstances), by any person who has been convicted of a crime and sentenced to a term of imprisonment (or its equivalent for young persons) of 3 months or more. The prohibition applies in all circumstances, including handling and firing at an approved shooting club or at a clay pigeon shoot where a certificate is not ordinarily required. It also applies to the possession or use of other categories of firearms and ammunition such as AIRGUNS or shot cartridges for which a certificate is not needed.

A sentence of 3 months to 3 years attracts a 5 year prohibition, shorter ones no prohibition but a longer one means a life ban.

Shooting at targets representing human beings or animals is not permitted as part of any Scout activity, nor on property owned or leased by, or used in the name of, the Scout Movement. **PAINT BALLING IS NOT PERMITTED.**

In no circumstances may any person handling any firearm at any Scout premises, campsite, camp or Scout project or expedition indulge in indiscriminate firing.

Members may practice shooting with air weapons of .177 inch (4.5mm) calibre or less which do not require a Firearms Certificate (except that in Northern Ireland a Firearms Certificate is always required) as follows:

- The ranges must be properly constructed to comply with guidelines issued by the NSRA or the NRA and with any by laws relevant to the location of the range.
- The guns used must not be of an automatic nature.
- The pellets used must be ‘diablo shaped’ and of soft deformable metal such as lead.
- The Range Officer must hold one of the qualifications listed within P.O.R and if any of those shooting under the age of 14, the Range Officer or another person supervising participants in the activity must be aged not less than 21.
- For a temporary range, the Range Officer shall proscribe appropriate range safety and other rules, taking account of the particular circumstances of the range.

In the event of any photographs being taken it is assumed that unless expressed to the contrary, in writing, that the person named overleaf can be photographed. These photographs may be published in Scouting magazine, local or national newspapers and used on the Bradford North District Scouts website.
